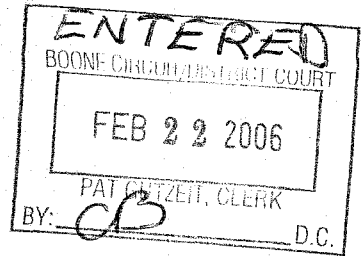

This matter was before the Court for a hearing on Plaintiffs' Motion for Partial Summary Judgment, Plaintiffs' Motion to File a Second Amended Complaint, Defendant Chesley's Motions to File an Amended Answer to the First Amended Complaint and for an Extension of Time to File a Response to Plaintiffs' Motion for Partial Summary Judgment, Joint Motion of Three Attorney Defendants to Seal Pleadings, and the KFHL's emergency Motion to disburse charitable funds on February 10, 2006, during which counsel for the parties were present. Since Defendant Chesley's Motion for Extension was filed the day before the hearing, the Court


proceeded to hear Plaintiffs' Motion for Partial Summary Judgment as to only the three other attorney defendants as well as argument on the remaining Motions. Accordingly, the Court being in all ways sufficiently advised;

Based upon representations made by Plaintiffs' counsel, IT IS ORDERED, that Plaintiffs' Motion to File a Seconded Amended Complaint shall be considered withdrawn;

IT IS ORDERED Defendants' joint Motion to Seal Pleadings is overruled;

IT IS ORDERED Plaintiffs shall be granted until February 20, 2006, within which to file a response to Defendant Chesley's Motion for Leave to File an Amended, Second Answer to the First Amended Complaint and for Additional Time to Respond to Plaintiff's Motion for Partial Summary Judgment.

IT IS ORDERED that the KFHL's Motion for disbursement of charitable funds shall remain under submission pending the filing of any supplemental pleadings by both parties on or before February 28, 2006.
