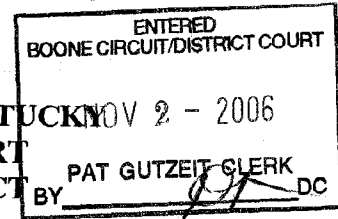

ORDER


The above matter came before the Court on the Motion of Richard D. Lawrence, a non-party witness herein for a protective order. The Court conducted a telephone conference with Angela M. Ford, attorney for Plaintiff and with Gary J. Sergent, attorney for Richard D. Lawrence on Thursday, October 26, 2006. Having heard the parties and it appearing that the parties are in agreement in several respects and the court being otherwise duly advised,

IT IS NOW ORDERED as follows:

1. The deposition of Richard D. Lawrence noticed for Monday, October 30, 2006 should be and the same hereby is canceled. The subpoena served on October 23, 2006 is withdrawn upon the representation of counsel for Mr. Lawrence that non-privileged documents relevant to the subpoena shall be provided to counsel for the Plaintiff within 7 days from after October 26, 2006. In addition, counsel for Richard D. Lawrence shall submit a privilege log to the Court and counsel no later than 7 days from and after October 26, 2006, I. E. Close of business on November 2, 2006.
2. The subpoena issued for Richard D. Lawrence for a deposition on November 3, 2006 shall be withdrawn by counsel for the Plaintiff. Counsel for the Plaintiff and for Richard

D. Lawrence have agreed to complete the deposition of Richard D. Lawrence on December 7, 2006, subject to the availability of counsel for the Defendants and subject to any medical emergency or necessity attached to the medical condition of the spouse of Richard D. Lawrence which has been disclosed to all counsel. In the continued deposition, questioning of Mr. Lawrence shall not be repetitive of the questioning in his deposition taken September 26, 2006.


