**ORDER**


**IT IS HEREBY ORDERED** that Plaintiffs' motion is hereby **GRANTED IN PART**. Specifically, Mr. Lawrence is ordered to produce to Plaintiffs' counsel the following documents as identified in Mr. Lawrence's Privilege Log by the following numbers: RDL 00002, RDL 00226, RDL 00229, RDL 00353-354, RDL 00395, RDL 00477-479, RDL 00483, RDL 00621-633, RDL 00746A-746D. These documents shall be produced subject to all previously entered

Orders regarding confidentiality.

**IT IS FURTHER ORDERED** that, as Plaintiffs' counsel informed the Court that she seeks no other documents identified in Mr. Lawrence's Privilege Log, Plaintiffs' motion to compel as to any documents described in Mr. Lawrence's but not listed in the preceding paragraph is hereby OVERRULED.

**IT IS FURTHER ORDERED** that counsel to the parties in this case may not contact any of the individual clients of Mr. Lawrence who may be identified or referred to in the documents to be produced and who are not presently clients of such counsel, without the prior consent of Mr. Lawrence or order of this Court after notice to Mr. Lawrence.
