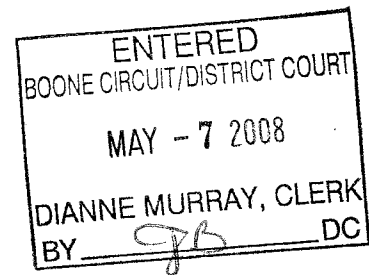




service upon the above witness, to assure the attendance of said witness as deponent in a deposition to be convened by the above counsel for the Plaintiffs within your judicial district.
