The Court having considered the Motion for Payment of Garnishment Proceeds filed by the Plaintiffs herein; having considered the written submissions of the parties; being satisfied that the Transamerica Occidental Life Insurance Company is possessed of property owned by the Judgment Debtor, Melbourne Mills, Jr. in the form of three annuity policies bearing policy #870551TO02A, policy #872024TO02A, and #880820TO02A; finding that the Plaintiffs are entitled to apply all payments accrued since October 15, 2007 and all future payments made under the aforementioned annuity policies against the Judgment entered in this action; and being otherwise duly and sufficiently advised,

IT IS HEREBY ORDERED AS FOLLOWS:


1. The Motion for Payment of Garnishment Proceeds is SUSTAINED;
2. Transamerica Occidental Life Insurance Company shall liquidate and pay all proceeds of annuity policies #870551TO02A, policy #872024TO02A, and #880820TO02A accrued from October 15, 2007 to the date of entry of this Order over to the designee of Plaintiffs to be applied to any outstanding amount due under the Judgment; and
3. Transamerica Occidental Life Insurance Company shall liquidate and pay all future proceeds of annuity policies #870551TO02A, policy #872024TO02A, and

#880820TO02A to the designee of Plaintiffs to be applied to any outstanding amount due under the Judgment until such time as the Judgment shall be paid in full.
